Members who contemplate breeding a litter, or who allow use of their stud dog for the same purpose shall direct their efforts toward producing dogs of quality, of even temperament, vigor, and free of health problems. They shall be familiar with the Bulldog Breed and its BCA/AKC approved standard and breed only those specimens that conform to it. Members shall not engage in false or misleading advertising of misrepresentation of their breed, nor shall they malign their competitors' dogs, breeding practices or person.
